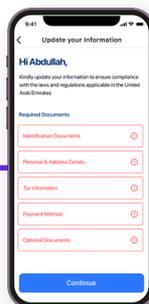

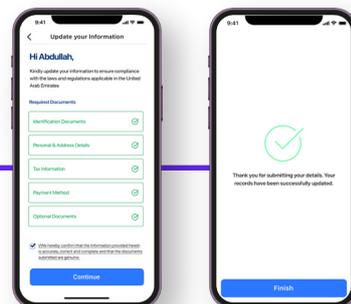

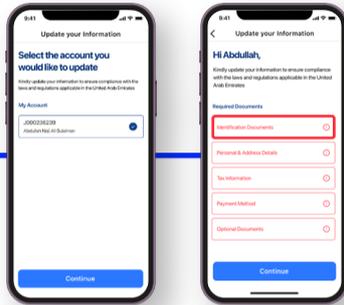


Tutorial: How to update your Identification Documents

Option 1: Emirates ID

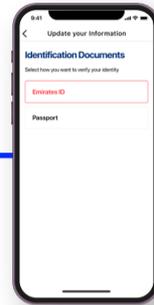
STEP 1

Select **Emirates ID** to continue updating your information.



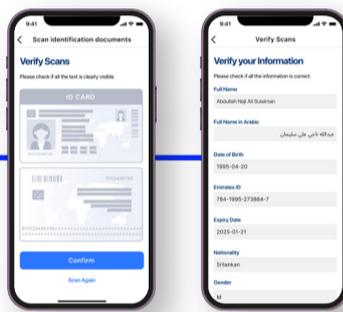
STEP 3

Follow all the necessary steps indicated on the journey. **Scan and update** information as requested.



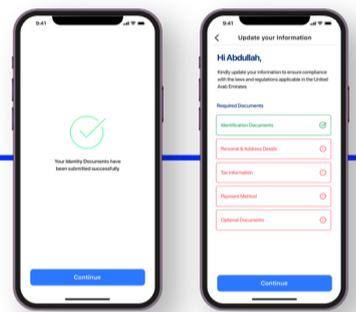
STEP 4

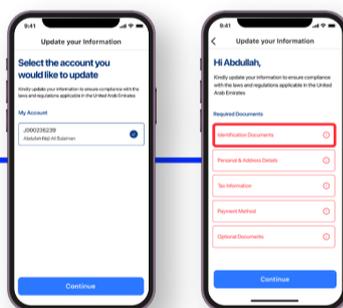
A **success screen** will confirm you have finalized your update, and in your Required Documents list, the **Identification Documents** tab will turn green.



Option 2: Passport

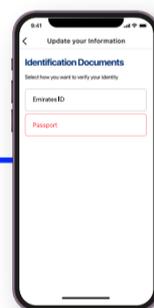
STEP 1

Select the account you would like to update and select **Identification Documents** tab.



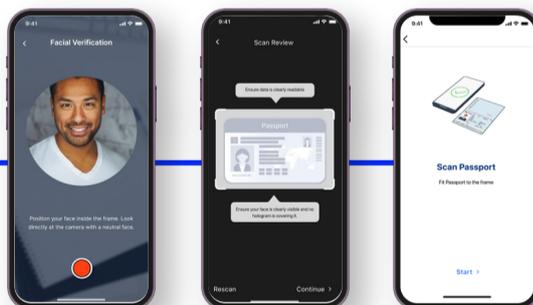

Select **Passport** to continue updating your information.



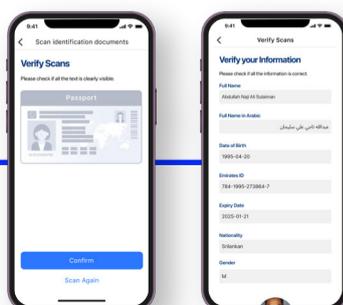

Follow all the necessary steps indicated on the journey. **Scan and update** information as requested.



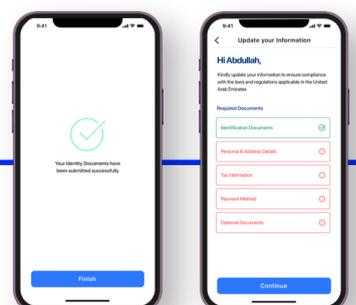

A **success screen** will confirm you have finalized your update, and in your Required Documents list, the **Identification Documents** tab will turn green.

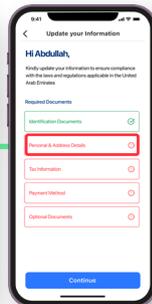




Tutorial: How to update your Personal Details

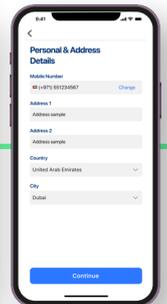
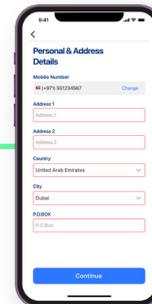
STEP 1

Select the account you would like to update and select **Personal & Address Details** tab.



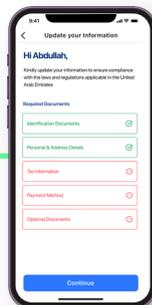

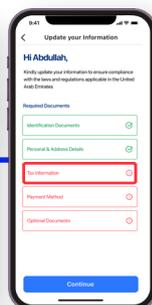
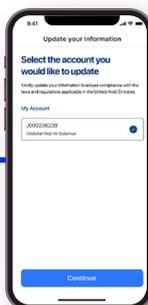

Tutorial: How to update your Tax Information

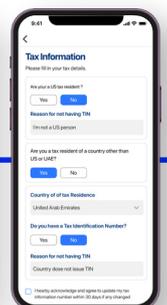
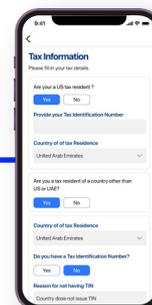

Select the account you would like to update and select **Tax Information** tab.



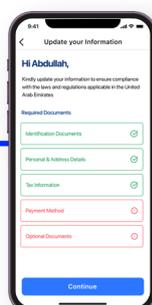
